**Testing Order and Time of Tests (order of tests by day):**

Re-testers must re-take the Official Practice Test (OPT) and pre-pay before they can schedule to re-test. Send new OPT scores to Linda or Sharon by mail or fax by the Friday before the preferred re-test date; then we will confirm the date. Re-testers are to report to the college by 7:45 a.m. for Math, by 9:30 a.m. for Writing and by 12:30 p.m. for Social Studies, Science or Reading with a **Legible Government Issued Picture ID**.

**Time to Arrive:**

No later than 7:45 a.m. with their legible Government Issued picture ID

**Required Documentation:**

- Government issued photo ID.
- Proof of Registration Page, signed Misconduct Policy, KYAE-6 form from GED123.org. KYAE-6 must be signed by the examinee, signed by the adult education provider with OPT scores entered and dated. State agency children, juvenile detention students and GED Secondary Program students need additional signatures on the KYAE-6 form
- GED Secondary Program students must have a scannable GED Option form available from the examiner and signed by the school district.

**NOTICE: No examinee may be admitted to testing unless the registration process is complete with all official documentation presented to the examiner. No examinee may be admitted to testing after the testing room door has been closed.**

All candidates must be pre-registered and pre-paid to take the test. To pre-register, you may fax the completed GED-123, high school withdrawal (if applicable) and pay voucher or receipt to Sharon Spann or Linda Bush at 270/554-6309 or mail to the address below. **ALL DOCUMENTATION MUST BE RECEIVED BY THE FRIDAY PRIOR TO PREFERRED TEST DATE.** We will contact you (Adult Ed Center) with the available test dates for your client after we receive all documentation to confirm a date. **The test will be given on the 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> Wednesdays or each month.**
